



FOSTER CARE AGREEMENT

The Foster Family agrees to foster the following animal (hereinafter called, "Animal") from Beare Garden Plantation Animal Rescue.

As a Foster Family, I/We agree to the following:

1. I/We understand the animal is currently named _____, and it is necessary for record keeping, appointments, public information, etc. to refer to the animal by this name.
2. To allow a representative of BGPAR if necessary, to visit my premises to insure the terms of this agreement have been kept.
3. The Animal will be provided with adequate fresh food and water, clean, dry shelter when outside, and daily exercise.
4. To obey all applicable laws governing control and custody of animals
5. To foster the Animal as a family companion only.
6. If fostering a dog, the Foster Family agrees to have a clean, secure fenced area for the dog. If a fenced enclosure is not available, Foster Family agrees to leash walk dog.
7. Foster Family agrees to bring the animal to veterinary appointments and adoption events or allow for BGPAR to make arrangements to make alternative transportation to get them to the appropriate appointments/events.
8. Foster Family understands that BGPAR retains legal control of the animal and is not authorized to make any legal or medical decisions on his/her behalf.
9. Foster Family agrees to allow potential adopters that BGPAR has approved to meet the foster Animal at the family home OR at another reasonable location.
10. Foster Family agrees to facilitate meetings with prospective adopters and answer questions by potential adopters.

11. Foster Family agrees to respond to BGPARG within twenty four hours concerning the animal and/or potential adopters.

12. BGPARG makes no guarantees or statements regarding the Animal's age, breed, health, or temperament. While BGPARG has made every effort to provide accurate history and assessment of the Animal, BGP is not able to guarantee the Animal's age, breed, medical status, behavior or disposition.

13. All medical expenses that are approved by the BGPARG Board and treated through BGP approved veterinary office will be covered by BGPARG. If you take our Animal to your vet it will not be covered.

14. Foster agrees to release BGPARG and its members or representatives of any and all possible claims arising from injury or damage caused by the animal to any person or property.

15. If you choose to adopt your foster animal. You will be required to fill out a adoption application. Upon receipt it will be processed to BGPARG guidelines.

As a Foster Family, I/We agree to release the previous owner as well as BGP Animal Rescue and its representatives of any liability arising from our duties as a Foster Family, from this date forward.

I/we agree to abide by the foster conditions and I/we have read and fully understand that BGP Animal Rescue may repossess this animal at any time if the foster conditions are violated or the animal is mistreated.
